*1. Foster agrees the cat is to be treated as a family companion and agrees to provide the cat with a safe home, adequate food, water, proper care, exercise, love and attention. Foster agrees not to violate any laws or ordinances with the cat. The cat is not to be used as an attack or protection trained cat and will not be used for commercial guard work.
